2.	Minutes of last meeting The minutes of the Parish Council Meeting held on 10 <sup>th</sup> June 2024 having been previously circulated were taken as read, approved and signed.

	Parishioners questions: Mrs Harvey had previously questioned by email who had been responsible for cutting and clearing the Alley Walk footpath as there were a considerable number of hawthorn remnants on the ground which are a risk to dogs. Cllr Jacobs responded by saying that it was always likely to be the case wherever hawthorns were cut, however would review the condition of the footpath.	AP1/07.24 DJ
	Mrs Harvey reported that Suffolk Day had been very successful, with a large number of people attending, and £850 raised for local charities. Suffolk Day will be on 21st June next year.	
	County Councillor's report: Cllr Mulcahy communicated by email to the Council that remedies were being scheduled for the Park Lane resurfacing and related flooding issues. Regarding poor	AP7/05.2 4/PM
	communication on road closures, she advised the use of the One.Network website in future. This site contains details of all planned road closures, including those not managed by Suffolk Highways. Cllr Cade requested that the situation of poor or zero cut back of the paths leading to/from the school be raised with Cllr Mulcahy.	AP2/07.24 CLERK
	District Councillor's report: Cllr Reeves said that the District Council was awaiting details on government policy following the General Election. He reported that there are a wide range of funded holiday activities across the district for disadvantaged children (details on Council website). Cllr Ninnmey reported on what he felt was a positive conversation with Tim Passmore (Police & Crime Commissioner) about the need to improve policing in rural areas. He also highlighted concerns about the increasing incidences of shoplifting in the Felixstowe area. Cllr Ninnmey reported that the DC were contributing £150 to the Church Hall defibrillator fund, which	

	has been a welcome initiative by the Judo Club. Regarding planning policy, he suggested this might be more "directive" in future, however he said that currently the Government's focus was on urban planning. He also said there was uncertainty over the future of the Felixstowe Peninsular Partnership, for which planning runs out in 2025. Cllr Cade raised concern about a recently received email from ESC regarding the building of additional 12 houses in the parish(es). It was completely unclear as to what it was trying to communicate, and requested this would be reported back.  PTLO: Nothing to report	AP3/07.24 CLERK

	vi) Church Hall defibrillator maintenance & smaller pads: Mr Beer (RG), responded by email concerning the use of smaller pads for juniors and received the following response from Community Heartbeat "Most defibrillators can be used on children down to the age of 1 year old. However, the guideline from the UK Resuscitation Council of GB, that if possible and under the 25kg threshold, paediatric electrodes should be used to reduce the shock level. However, if there are no Paediatric Pads or reducing current device available, then adult electrodes can be used but placed front and back of the patient. In reality this means that the chance of using a defibrillator on a child under the age of 7 years old in an average community in the UK is about 1 in 3000 years. The chance of that defibrillator being used on an adult in the community (ie over 8 years old) is 1 in 1000 people per annum. In simple terms, it is more likely to be used on the adult many times more than an under 8 years of age child."  vii) Road closure communications: See County Councillor's report ongoing action (AP7/05.24/PM)	
	ix) VG grass cutting: Concern was raised about the nature and frequency of cutting the Village Green, which will be investigated in order to determine the best practice going forward. In general the desire was to leave the first cut until the end of May, however it was acknowledged that the extreme growing conditions experienced this year have proved challenging, and could continue in future years.  x) Tree Warden: Situation remains vacant	AP4/07.24 CLERK
